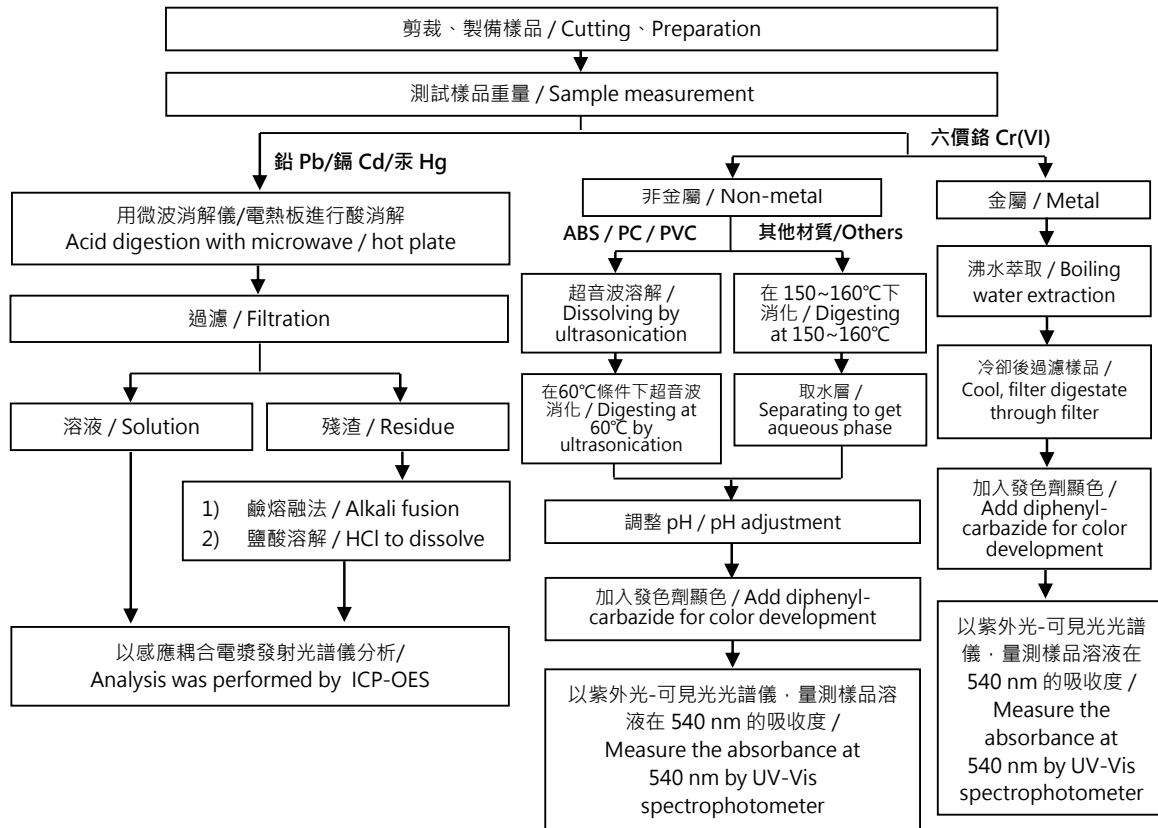

### 六溴環十二烷分析流程圖 / Analytical flow chart - HBCDD

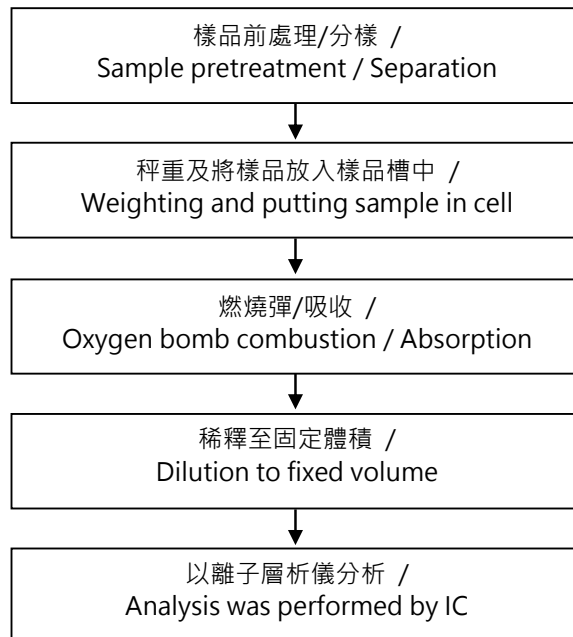

### 鹵素分析流程圖 / Analytical flow chart - Halogen

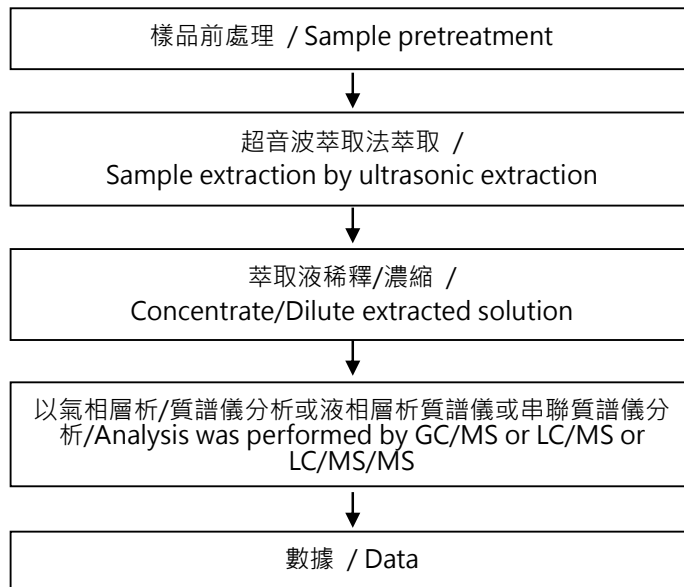

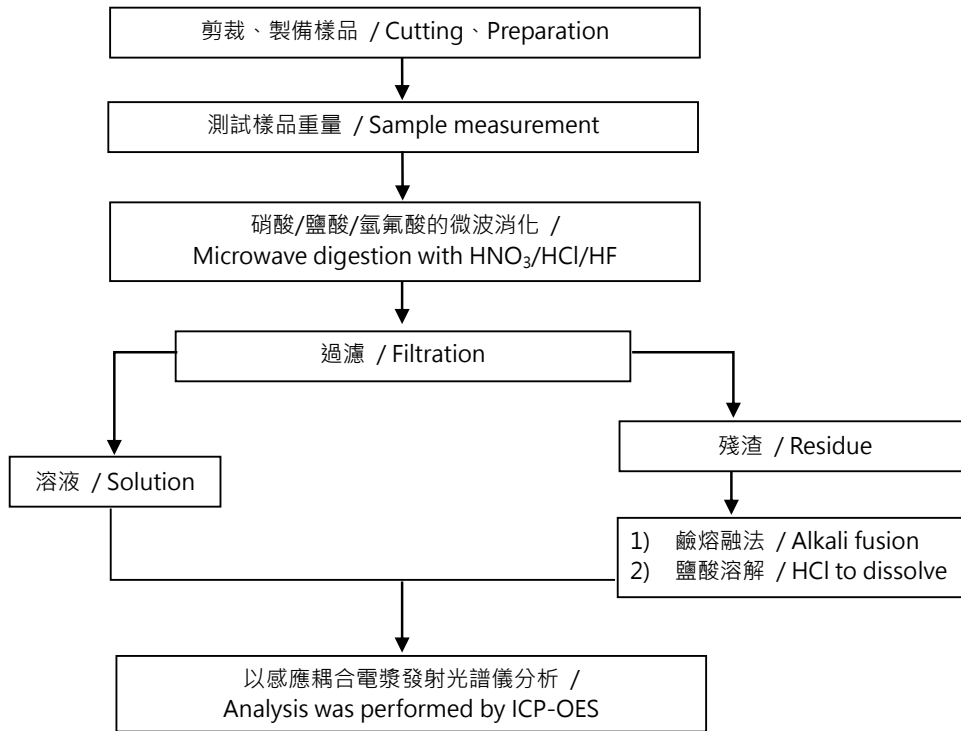

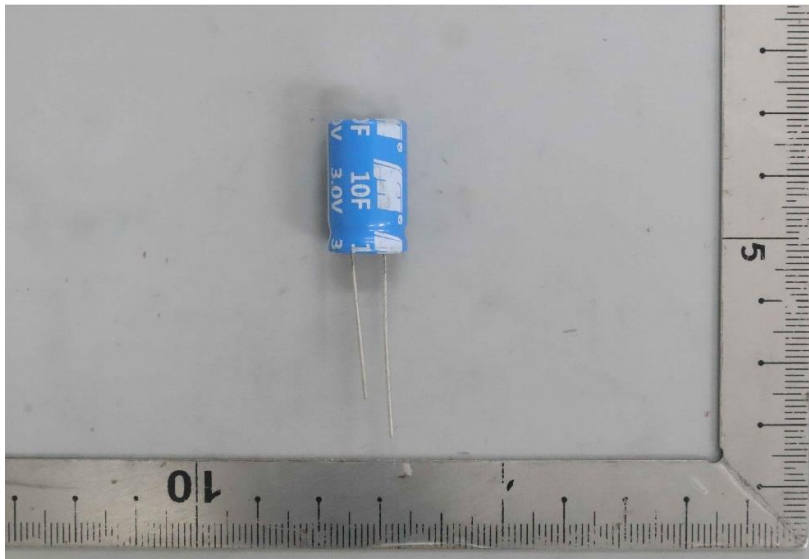
